

Outgoing Mobility Requirements of the Degree in Medicine

International internships

1. When can I study abroad?

From 3rd to 5th academic year, for a semester or a complete academic year.

2. Is a minimum cut-off mark required?

Yes, 1.5 (from 0 to 4) or 6.6 (from 0 to 10).

3. Is it possible to have pending subjects?

A maximum of 2 pending subjects or 15 ECTS will be allowed at the time of application, but no pending subjects will be allowed at the time of going abroad.

4. Where can I apply for studying abroad?

In international institutions that have agreements in place with UIC Barcelona.

5. Can new agreements be set up?

Yes, new agreements can be set up and will be evaluated and aproved by the School of Medicine Dean's Office.

Any interested student will have to fill in the form "Application for setting up a new agreement".

- Only international agreement proposals will be accepted for evaluation.
- The new agreement will have to be approved by the School of Medicine Dean's Office.
- The student will check compatibility of curriculums.
- The proposed agreement will be signed as long as its continuity is ensured (preferably for more than one student and for a time period of at least 2 years).

International practice rotations

1. How long can an international internship last?

16 weeks at the most and in a single centre.

2. When?

From june/July to December.

3. Is a minimum cut-off mark required?

Yes, the cut-off mark is 1.5 (from 0 to 4) or 6 (from 0 to 10). No student with marks lower than these can apply for an international internship.

4. Is it possible to have pending subjects?

A maximum of 2 pending subjects or 10 ECTS will be allowed at the time of application, but no pending subjects will be allowed at the time of going abroad.

5. Where can I apply for studying abroad?

International institutions that have agreements in place with UIC Barcelona will be prioritized.

Proposals of new agreements will be evaluated and approved by the School of Medicine Dean's Office.

6. Can new agreements with hospitals or universities be set up?

Yes, with both hospitals and universities.

7. What characteristics will international institutions have to meet for receiving internship students?

- To have undergraduate training capabilities.
- To have enough training activity to facilitate learning.
- To assign a tutor to supervise the student directly.
- To perform a final evaluation of the student internship.
- Values and principles of the centre must be compatible with those of UIC Barcelona.

8. How can new agreements be established?

- International institutions will be prioritized. Read next section "National Practice Rotations" for specific requirements applicable to national institutions.
- The student will have to fill in the form "Application for setting up a new agreement", subject to approval by the School of Medicine Dean's Office.
- The proposed agreement will be signed as long as its continuity is ensured (preferably for more than one student and for a time period of at least 2 years).
- In case of an internship in a hospital, the document "Cooperation Agreement" (individual for each student) will have to be signed.

9. What practice rotation subjects can I do abroad?

Any practice rotation subject except for Health and Social Care Rotation and Primary Care Rotation, which will require previous approval by the Grade Mobility Commission according to the characteristics of the host country.

National practice rotations

1. Is a minimum cut-off mark required?

Yes, an academic record higher than 2 will be required at the time of application, without any pending or failed subject in previous academic years.

2. Is it possible to have pending subjects?

No pending subjects will be allowed at the time of going away.

3. Will applications for any Spanish province be accepted?

No application for Barcelona province will be admitted.

There are provinces that do not allow practice rotations of undergraduate medical students: Comunidad Valenciana, Murcia, Pais Vasco, Navarra,..other provinces

request payment of a fee to students,...The student will have to check applicable conditions and ensure feasibility of national practice rotations before applying.

4. Can new agreements be set up?

Yes, new agreements can be set up with <u>hospitals</u> that meet the requirements for practice rotations (see point 6), as long as they have previously been approved by the School of Medicine Dean's Office.

5. How can new agreements be established?

- The student will have to fill in the form "Application for setting up a new agreement", subject to approval by the School of Medicine Dean's Office.
- Only proposals of new agreements with national hospitals admitting students from other provinces and not in the Barcelona province will be accepted for evaluation.
- New agreements will have to be approved by the School of Medicine Dean's Office
- The student will have to facilitate the contact of the centre's training secretary to UIC Barcelona.
- The proposed new agreement will be signed as long as its continuity is ensured (preferably for 3 years).

6. What characteristics will national institutions have to meet for receiving students for practice rotations?

- To have undergraduate training capabilities.
- To have enough training activity to facilitate learning.
- To assign a tutor to supervise the student directly.
- To perform a final evaluation of the student rotation.
- Values and principles of the centre must be compatible with those of UIC Barcelona.
